**BEHAVIOR AND TRAINING**

Friends continued to fund the Behavior and Training program at the shelter which provides assessment, training, socialization, field trips and treats for available animals at ACC. Friends also funded continuing education for ACC volunteers in areas such as: senior dog care, working with shy dogs/puppies, clicker games and cat handling.

**RESCUE PARTNER GRANTS**

The success of ACC is due in part to partnerships with rescue groups. FSFACC provided rescue grants to over 17 rescue partners totaling \$48,525. These grants enable our partners to provide medical care and training to some of the animals they take from ACC.

**OUTREACH and FUND-RAISING EVENTS**

FSFACC continues to support the shelter by participation in a number of outreach and fund-raising events. Throughout the year FSFACC partnered with Halo, Pet Food Express, WAG Hotels, DogFest, Pet Camp, Maddie's Fund, Million Dog March, and the SPCA to bring awareness to the shelter and raise funds. In addition Friends hosted the 20th year for Pet Pride Day, a fun, free event for the public.

**HUMANE EDUCATION**

FSFACC continued with the after school program partnering with a local elementary school. Over the course of 10 weeks, Kindergarten through 2nd grade students met 10 different kinds of animals available for adoption at San Francisco Animal Care and Control. In addition, the students made toys, treats and habitats to bring to the

#### Service Learning

In addition Friends added a service learning program and a summer camp. She was adopted in the summer to a loving family as well.
