ANIMAL BEHAVIOR AND TRAINING: Friends continued to fund the shelter's Behavior and Training effort, which provides assessment, training, socialization, special treats and toys, and field trips for the shelter animals to improve their behavior, well-being and "adoptability". Friends funding in this area also provided consultants and training for the shelter volunteers in areas such as senior dog/cat care, shy dog/cat handling, puppy/kitten care, dog clicker games and cat handling. ANIMAL RESCUE PARTNER GRANTS: The shelter's success is partly due to its partnerships with other non-profit animal rescue organizations. Friends disbursed grants to 20 rescue partners serving a range of animals including cats, dogs, rabbits, birds, rodents, reptiles, amphibians and fish. These grants help offset the cost of training and medical care for the animals the rescue partners take from the shelter. VETERINARY SERVICES AND SUPPLIES: Friends continued to provide the Emergency Medical Fund for animals requiring extraordinary veterinary care. During the year, Friends paid for one emergency medical procedure. Friends also continued to underwrite the shelter's quarterly Low-Cost Rabies/Microchip Clinics, paying for the rabies vaccine and microchips, as well as for the outside (non-shelter) veterinarians and veterinary technicians who work at the clinics. Each clinic provided rabies
